STEP 2	ASAP, no later than 20 April 2020	Determine whether you qualify for the JobKeeper scheme.	See the Eligibility section of the Employsure JobKeeper FAQ.
STEP 3	No set timeframe	<b>OPTIONAL:</b> If you don't qualify or decide you don't want to participate in the JobKeeper scheme, inform your employees.	Memo to your employees confirming you will not be participating in the JobKeeper scheme.
STEP 4	ASAP, no later than 20 April 2020	Determine your eligible employees.	See the Eligibility section of the Employsure JobKeeper FAQ.
STEP 5	ASAP, as employees must return the completed form to you no later than the end of April	Issue your eligible employees with a memo requesting them to complete the ATO's JobKeeper Employee Nomination Notice form.	Memo to your employees with the ATO's JobKeeper Employee Nomination Notice form attached, explaining the employee must complete and return the form within the specified timeframe.
STEP 6	No set timeframe	OPTIONAL: Inform employees who are not eligible.	Memo to those employees who are not eligible for JobKeeper payments.
STEP 7	20 April onwards	Enrol with the ATO using the <u>Business Portal</u> .	
STEP 8	20 April onwards	Receive correspondence from ATO confirming whether your business has qualified or not.*	
STEP 9	20 April onwards (and no later than 30 April)	IF ATO HAS CONFIRMED YOU QUALIFY: Issue eligible employees with a confirmation of your business qualifying for the JobKeeper scheme and payment being made.	Memo to your employees confirming that the business qualifies for the scheme and has made payment (if required) to ensure the EE has been paid at least \$1,500 per fortnight for the period of 30 March 2020 to 26 April 2020.
STEP 10	20 April onwards (and no later than 30 April)	IF ATO HAS NOT CONFIRMED YOU HAVE QUALIFIED, OR REJECTED YOUR APPLICATION: Inform your employees of your situation.	Issue one of the below, depending on your situation: Memo to your employees confirming that the ATO has notified you that the business does not qualify for the scheme Memo to your employees confirming that the ATO has not yet confirmed whether the business qualifies, but you are making the business decision to make JobKeeper payments despite this Memo to your employees confirming that the ATO has not yet confirmed whether the business qualifies, so you will not be making JobKeeper payments for April
STEP 11	20 April onwards (and no later than 30 April)	If you are seeking reimbursement for April JobKeeper payments, ensure eligible employees have been paid the minimum \$1,500 per fortnight for the two fortnights covering 30 March 2020 to 26 April 2020.**	
STEP 12	4 May onwards	Apply online with ATO to claim first two fortnights (covering 30 March 2020 to 26 April 2020).	Memo to your employees within 7 days of applying online, confirming their details have been submitted to ATO (this is a legal requirement)
STEP 13	4 May onwards	Receive payment from ATO for first two fortnights.	
STEP 14	May onwards	Continue to pay employees the JobKeeper payments, and comply with the ATO's monthly reporting requirements.
