

Principal Child Protection Practitioner

INFORMATION FOR EARLY CHILDHOOD EDUCATION AND CARE PROFESSIONALS

A Principal Child Protection Practitioner is an experienced practitioner employed by the Department of Communities, Child Safety and Disability Services and based at each Family and Child Connect.

The Principal Child Protection Practitioner works collaboratively with local government and nongovernment service providers to support the earlier and more effective intervention with children and families who have been referred for help. The Principal Child Protection Practitioner provides consultancy and advice on child protection matters, as well as education on statutory child protection processes and responsibilities.

Responsibilities

The Principal Child Protection Practitioner is responsible for:

- providing a case consultation service to the Family and Child Connect on complex cases and ensuring cases that may require statutory intervention are referred to Child Safety when necessary
- providing professional child protection advice and guidance in accordance with Child Safety policies and procedures, statutory responsibilities, Child Safety objectives and current trends
- building the child protection expertise of the Family and Child Connect and other government and non-government

- organisations through training and professional development initiatives
- supporting the implementation of the Child Protection Guide by providing training and education to schools, police and health professionals
- performing a cross-sector coordination role to enhance collaboration between Child Safety and other government and non-government service providers
- establishing and maintaining effective working relationships, and actively participating in meetings with Family and Child Connect and other government and nongovernment service providers, as a representative of Child Safety.

Family and Child Connect service locations

A Principal Child Protection Practitioner will be located in each of the 17 Family and Child Connect services to be established across Queensland.

Family and Child Connect are now operating in the following catchments:


