Dangerous/sharp objects are removed eg glass, broken windows, syringes					
Dangerous items are inaccessible to children eg power tools, screwdrivers					
Sharp surfaces are smoothed or children's access to them blocked eg					
protruding screws, splintered wood, sharp edges					
Garbage is inaccessible to children					
Hazardous storage area is locked					
Any animal waste or sharp objects removed from sandpit					
Water storage containers are empty or inaccessible to children					
Sharp, poisonous, allergy causing plants are removed					
Dangerous animals or insects eg wasps, redback/funnel web spiders, snakes					
are removed					
Broken equipment is removed					
Objects which children may use to climb over fence are removed					
Under centre – no access					
Fly screens secure					
Environment clean and tidy. Rubbish removed.					
Floors, stairs, steps, paths are non-slip					
Loose fill materials are deep enough					
Sandpit clean with no animal poo or sharp objects					
Water Storage Containers empty /inverted					
Inside					
Dangerous items are inaccessible to children eg knives, scissors					
Children's artwork – away from fans and heaters					
Doors unbroken and have finger jam protectors					
Electrical cords and cords from blinds and curtains inaccessible to					
children, especially in cot room					
Safety plugs cover unused electrical outlets					
Nappy buckets are inaccessible to children					
Hazardous chemicals, medicines, knives stored in locked cupboards					
Broken equipment or resources are removed					
Trip hazards removed eg curling mats					
Hot drinks are out of reach for children					
Kitchen, laundry, storage areas inaccessible to children
