Management, educators and staff are aware of their roles and responsibilities to identify and respond to every child at risk of abuse or neglect.

Looking at the element in detail - A service reviewed what the NQF Guide said about element 2.2.3 and understood all employees must be aware of:

- the current child protection policy and procedures
- their legal responsibilities, roles and responsibilities to identify and respond to every child at risk of harm, abuse or neglect.

The theme for National Child Protection Week (4-10 September 2022) is 'safe and supported' — ensuring all children can grow up in a safe and supported environment.

We recently issued new Child Safe Policies to all customers. These are based on the national Child Safe Principles. For NSW and Victoria customers, the policies cover specific Child Safe Standards enshrined in State legislation (which have adapted the national Principles). NSW and VIC services are required to have policies which show how they meet the State Standards/Principles. South Australia has also committed to implement the national Principles and SA customers must have a Child Safe Policy.

Policy Review

Child Protection Policy

The Approved Provider, Nominated Supervisor, employees, volunteers and students will:

- o be trained in their child protection obligations so they can confidently
 - o identify indicators of abuse
 - o manage disclosures or suspicions of abuse/neglect
 - report abuse/neglect to relevant authorities including any made involving employees, volunteers, students
 - o prepare accurate records to assist investigations and store them securely
- always take anything a child says seriously and follow up their concerns
- o maintain the confidentiality of all parties involved in an investigation
- o keep their child protection clearance current (eg working with children check) unless exempted under the law.

Child Safe Policy NSW Only

Our Service commits to an environment and practices which are consistent with the NSW Child Safe Standards:

- 1. Child safety is embedded in organisational leadership, governance and culture
- 2. Children participate in decisions affecting them and are taken seriously
- 3. Families and communities are informed and involved
- 4. Equity is upheld and diverse needs are taken into account
- 5. People working with children are suitable and supported
- 6. Processes to respond to complaints of child abuse (or other concerns) are child-focused
- 7. Staff are equipped with the knowledge, skills and awareness to keep children safe through continual education and training
- 8. Physical and online environments minimise the opportunity for abuse or other kinds of harm to occur
- 9. Implementation of the Child Safe Standards is continuously reviewed and improved
