Exceeding – Critical reflections. Current recognised guidance informs our approach to supporting families. The MTOP is based on socio-cultural theory that says children learn through the relationships they have with their families and community. Providing appropriate support to families assists children to learn and develop. We adopt current recognised guidance from Red Nose, Kidsafe, Nutrition Australia, and the federal government's physical activity guidelines.

Critical reflection is a valuable tool for educators to evaluate and improve their practice by identifying areas of strength, areas for improvement, and potential solutions to challenges. It involves questioning assumptions, considering alternative perspectives, and engaging in ongoing self-evaluation and learning.

Current recognised guidance. Refers to the official documents, frameworks, and guidelines that have been developed by relevant authorities and experts in a particular field, industry, or sector. In the context of early childhood education in Australia, these guidance materials provide educators with best practices and recommendations for supporting children's learning and development, as well as building strong relationships with families.

Supporting relationships with families. Refers to the process of building positive and collaborative connections between early childhood educators and the families of the children in their care. This involves establishing a partnership with families, based on mutual respect, trust, and open communication. Supporting relationships with families is essential in early childhood education because it enables educators to gain a better understanding of each child's individual needs, strengths, and interests.

In Australia, My Time Our Place (MTOP) is a nationally recognised guide for early childhood educators to support and enhance children's learning from birth to five years of age. The MTOP emphasises the importance of building strong relationships with families as a foundation for effective early childhood education.	
According to the MTOP, building positive relationships with families involves respecting and valuing each family's unique culture, background, and experiences. This includes engaging in open and honest communication with families, actively listening to their perspectives, and involving them in their child's learning and development. Early childhood educators can also support families by providing information and resources, offering opportunities for involvement and collaboration, and fostering a sense of community and belonging.
