Exceeding – Critical reflections. We reflect on ethical issues and make changes accordingly. This includes:

- addressing cultural issues
- practising change to add more supportive structures for families
- providing support to particular families in regards to behaviour of children
- supporting partnerships with community organisations
- taking action to promote inclusion and participation of children
- changing administration financial management practices including removing bonds.

Ethical issues typically involve questions of what is right or wrong, and a team reflection means that they thought together about this issue.

**Description:** This part is about explaining what actions or adjustments were made as a result of the team's reflection on the ethical issue. Did the team decide to change policies, procedures, or behaviours to ensure that they are acting in an ethically sound manner? The focus is on any improvements made to ensure ethical practices are upheld.

Child Privacy and Consent: The early childhood education team reflects on the issue of obtaining parental consent for sharing photos and information about children on social media and in promotional materials. After the reflection, the team decides to implement a more robust consent process, including clear communication with parents about how their child's information will be used, and giving parents more control over what is shared.

#### Inclusive Education for Children with Disabilities:

Educators discuss the inclusion of children with disabilities and the importance of providing appropriate support. Following the reflection, the team decided to develop individualised education plans for children with disabilities, collaborate with specialised therapists, and offer professional development opportunities for staff to better support these children.

**Cultural Sensitivity:** The childcare centre staff reflects on cultural sensitivity and the need to respect the diverse backgrounds of children and their families. After the reflection, the team decided to incorporate more culturally inclusive practices, such as celebrating cultural festivals, offering multilingual resources, and encouraging cultural exchanges among children.

**Staff-Child Interactions:** The team reflects on the appropriate boundaries and interactions between staff and children. After the reflection, they established clear guidelines for appropriate physical contact, communication, and behaviour with children, ensuring a safe and respectful environment.

Transparency in Billing and Fees: The administration team reflects on billing practices and fee transparency for parents. After the reflection, they revamped the fee structure, provided itemised billing statements, and held regular meetings to address parent concerns and ensure that billing practices were ethical and transparent.
