as loose playground equipment, tripping hazards, or damaged furniture.

**Risk Assessments:** Educators can conduct regular risk assessments of the physical environment to identify potential dangers and take preventive measures.

**Safety Training:** Providing staff with training on safety protocols and procedures ensures that everyone is well-prepared to handle emergencies and maintain a safe environment.

**Emergency Drills:** Conducting regular emergency drills, such as fire drills or evacuation exercises, helps prepare both educators and children for unexpected situations and reinforces safety procedures.

**Hygiene Education:** Educators can teach children about proper handwashing, personal hygiene, and cleanliness habits, emphasising the importance of staying healthy.

Collaboration with Families: Maintaining open communication with parents and caregivers allows educators to address concerns, gather feedback, and work together to maintain a safe and clean learning environment.
