### Law & Regs

#### **Regulation 157 Access for Parents** - Penalty \$1,000

- (2) & (2) The approved provider and nominated supervisor ... must ensure that a parent of a child ... may enter the ...service premises at any time that the child is being educated and cared for by the service.
- (4) ... the approved provider or nominated supervisor is not required to allow a parent to enter ... if—
  - (a) permitting the parent's entry would—
  - pose a risk to the safety of the children and staff of the education and care service; or
  - conflict with any duty of the provider, supervisor or educator under the Law; or
  - (b) they reasonably believe that permitting the parent's entry would contravene a court order.

While parent involvement is generally encouraged to promote an open and inclusive environment, the centre has a duty to ensure the well-being and educational engagement of all children. Miss Thompson can address the issue by diplomatically discussing with Izzy's mother how the visits may be impacting the children's focus and learning experience. She can suggest alternative times for visits that would be less disruptive.	
Mr. Carter is considering if there are situations where refusing entry is justified, such as when a parent is abusive towards educators. What is the appropriate procedure for dealing with these scenarios?	It is critical to maintain a safe environment for both children and staff. If a parent's behaviour is abusive and threatens this safety, the service is justified in taking measures to limit or prohibit entry and call the police. The procedure should include documenting all incidents, informing the parent of the specific reasons why their behaviour is unacceptable, and, if necessary, advising them of the conditions under which they may be permitted to return. Don't ever be afraid to call the police.	
Miss Evans has requested clear examples of instances where they can legally deny entry. Could you offer some advice on this issue?	A parent or visitor whose behaviour poses a threat to the safety of children or staff, . Enforcement of court orders such as restraining orders that legally restrict the individual's access to the facility or access to the child/ren.
